6. Qualifications requirements include:
  - Average annual turnover for years 2007, 2008 and 2009 , are at least:
    - 400 000 PLN

A margin of preference for certain goods manufactured domestically shall not be applied. Additional details are provided in the Bidding Documents.

The set of bidding documents in English is free of charge and will be sent to the Bidders in a hard copy and, if requested, by email or on CD-ROM.
